## PRINT RECOMMENDATIONS

On most solvent-based machines, pre and post heat settings should be higher than when printing on vinyl film or fabric. Set at highest resolution, print mode "best" and media type "textile" or "backlit". For the best results on Roland and other Eco Solvent machines, the use of an external heater is recommended.

## WARRANTY

**What is covered?** This warranty covers Sunbrella Inkjet White from becoming unserviceable because of loss of color or strength from normal exposure conditions, including sunlight, mildew, rot, and atmospheric chemicals. It does not cover graphics printed on the fabric or labor and installation provided by the dealer.

**How long is the coverage period?** The warranty runs for three years from the date of original installation.

**What will Glen Raven do?** Glen Raven will supply new fabric free of charge to replace the fabric, which becomes unserviceable.

**How can you get service?** Call the dealer from whom you purchased the product to inspect the installation. The dealer will call Glen Raven and secure replacement fabric for you.

**How does state law apply?** This warranty gives you specific legal rights and you may have other rights, which vary from state to state.
